OTHERS:

MINUTES OF THE PREVIOUS MEETING WERE REVIEWED AND A MOTION TO ACCEPT THEM WAS MADE BY BRUCE DURANT AND SECONDED BY BILL HULL. THE MINUTES WERE THEN APPROVED BY UNANIMOUS CONSENT.

OLD BUSINESS: AMBER FETTERLY HAS PUT IN TWO APPLICATIONS FOR A GARAGE AUTO REPAIR AND A HARDWARE STORE ON THE JENNER ROAD. ALICE AND STEVE REED HAVE GOTTEN A DUMPSTER TO PUT GARBAGE IN ON THE OLD WATSON'S CHEVY PROPERTY. THEY PLAN ON CLEANING THAT UP THIS SUMMER.

FIREWALLS NEED TO BE CONSTRUCTED IN THE GRASSE RIVER HOUSING TO BRING THEM UP TO FIRE CODE. ACCESS TO THESE AREAS ALSO HAS TO BE INCLUDED AS THEY WILL CONTAIN INDEPENDENT DETECTORS TO EACH AREA.

DISCUSSION ENSUED ON AUTO REPAIR AND LUMBER YARD IN RA AND DERELICT VEHICLES ALONG THE ROADSIDE WITHIN THE TOWNSHIP. THE CODE NEEDS TO BE AMENDED TO REFLECT THAT AUTO REPAIR IS A PERMITTED USE IN RA AND THAT LUMBER YARDS WOULD ALSO

BE PERMITTED BY ANNUAL PERMITS WHICH WOULD PROVIDE ASSURANCES THAT OWNERS WOULD CONTINUE TO COMPLY WITH RESTRICTIONS AS DESCRIBED IN THE CODE. THIS WOULD INCLUDE PARKING, SETBACKS AND FIRE CODE AMONG OTHER POSSIBLE CONCERNS THAT MIGHT ARISE.

SEVERAL HOMES ARE BEING PUT ON NOTICE FOR NOT COMPLYING WITH THE CODE DUE TO REFUSE AND GARBAGE BEING PRESENT ON THE PROPERTY. JEFF GILSON WILL MAKE VISITS AND WRITE LETTERS TO NOTIFY THOSE WHO ARE NOT IN COMPLIANCE WITH CODE.

ALLEN KELLY WILL CONTACT THE COUNTY TO REQUEST INFORMATION ON DERELICT CARS. SOME CURRENTLY ARE STORED ALONG THE ROADSIDE EVEN WITHIN THE HAMLET. THE CODE NEEDS TO HAVE LANGUAGE INCLUDED WHICH PROHIBITS STORAGE OF DERELICT VEHICLES ON THE ROADSIDE FOR PROTRACTED PERIODS OF TIME. IT HAS BECOME A PROBLEM BOTH IN THE HAMLET AND OUTSIDE THE HAMLET IN RURAL AREAS.

ALLEN WILL WRITE A LETTER TO REQUEST THAT THE COUNTY PLANNERS ASSIST WITH CHANGING THE LANGUAGE IN THE CODE TO REFLECT CHANGES IN RA ZONES WHICH WERE PREVIOUSLY APPROVED BUT WERE NOT MADE. ALSO MORE SPECIFIC LANGUAGE TO ADDRESS DERELICT VEHICLE STORAGE AT RESIDENCES BOTH IN AND OUT OF THE HAMLET.

NEW BUSINESS: No new business was before the board on this date.

Motion to Adjourn was made by Bill Hull and seconded by Bruce Durant The meeting was adjourned at 7:10.
